“AUTUMN IN THE PARK” FOOD VENDOR TERMS AND CONDITIONS

1. Applications must be accompanied by a check in the amount of **\$250** payable to **TCPC AUTUMN IN THE PARK**. This is a guarantee of good intention to attend the show and is non-refundable unless application is denied. A photograph of your booth is required as it is our intention to provide a professional food court atmosphere.
2. Vendors are responsible for collecting and paying their own sales tax.
3. A limited number of electrical outlets are available for use. You must provide your own electrical cords and indicate your needs on the application under space requirements.
4. We will provide a limited number of tables and chairs for customers. You are welcome to bring some of your own.
5. **We try to guarantee exclusive rights to the food product you list on your application when possible.** If there is a conflict with another concessionaire, the right to sell certain items will be decided by the Autumn in the Park Committee with consideration being given to the first application received. Food Vendors are to be present on Saturday AND Sunday of the event.

(NO REFUNDS WILL BE MADE ONCE THE SHOW IS IN PROGRESS.)

6. The Treasure Coast Pilot Club will be selling Coco Cola products as well as bottled water. **NO OTHER CONCESSIONAIRE MAY SELL SOFT DRINKS OR BOTTLED WATER.**
7. The show hours will be Saturday, October 6th from 9 AM until 5 PM, and Sunday, October 7th from 9 AM until 4 PM. You may set up on Friday, Oct 5th, from 2:00 PM until 9:00 PM or from 7 AM until 9 AM on Saturday, October 6th. Overnight parking in designated areas is permitted and a security guard will be on duty during this time. Bathroom facilities are located at the North end of the park.
8. Vendors must supply their own coin/currency for change.
9. **VENDORS ARE RESPONSIBLE FOR THEIR OWN GARBAGE PICKUP AND DISPOSAL. Vendors must provide their own garbage bags and containers.** Dumpsters are located at the North end of Riverside Park for your convenience. **If garbage is too heavy, contact a club member to provide a golf cart for transporting to dumpster location.**
10. **NEW:** Tents up to 20X20 are allowed to cook at the edge of the tent. LP Gas Tank must be secured in place (max. capacity-20 lbs.). Fire extinguisher must be readily available. LP Gas tank large than 20 lbs. shall be 10 feet from tent with gas line secured to prevent public access or a tripping hazard. Class K-type fire extinguisher is required for vendors that are deep frying. All food cooking concession trailers and structures of rigid construction must have a commercial system, and must also comply with fire extinguisher requirements as follows: One (1) minimum rated (2A 10BC) currently tagged and inspected.
11. Vendors are responsible for observing State regulations. A \$91 event fee is assessed for each vendor without a license. Direct any questions you may have about these rules and regulations to the Department of Business and Professional Regulations in Orlando: 850-487-1395.
12. Should TCPC Autumn in the Park be cancelled due to inclement weather, as deemed necessary by Vero Beach city officials, entry fee will be refunded minus a \$25.00 processing fee.
